



Project Description:

The work generally consists of the repair and resurfacing of four existing asphalt roads. In addition, the work includes the re-establishing of soil shoulders along the resurfaced roads. Estimated roadway length = 3,580 feet.

SPECIAL CONDITIONS

The Bids must be submitted on the bid form. Submit one (1) signed original and two (2) signed copies of the bid form. Bids made otherwise will be subject to rejection. The above **Bid #** must be shown on the front of the envelope in which this bid is submitted. York County assumes no responsibility for unmarked envelopes being considered for award. An authorized company representative is required to sign in the place indicated on the bid form. **Bids not signed will automatically be rejected.** It is requested that completed bids be either typewritten or handwritten in black ink only. **Facsimiles are not acceptable.** If County offices are closed due to inclement weather, the bids shall be opened at the same scheduled hour on the 3rd working day (excluding County observed holidays) after the scheduled bid opening date.

5. Address and mark proposal as indicated in the notice.
